For requirements &amp; exceptions <a href="#">click here</a> for Proclamation 20-040</li> <li>✓ Amendment raising mandatory minimum age for children wearing facial coverings from age 2 to 6 years old. <a href="#">Click here</a> for Proclamation 20-041</li> </ul>	<p><b>BEACHES</b></p> <ul style="list-style-type: none"> <li>✓ COVID-19 related parking restrictions at all City owned &amp; operated parking lots are lifted</li> <li>✓ Fines for illegal parking are \$200.00</li> <li>✓ Temporarily prohibited possession &amp; consumption of alcoholic beverages from 7am to 5pm at all City operated beaches and associated parks and picnic areas with paid public parking (i.e., Bowman's Beach, Blind Pass, Tarpon Bay Beach, Gulfside City Park (Algiers), Lighthouse Beach and Fishing Pier, and Trost Parking Lot), as well as the beach area at the northern terminus of Bailey Beach Road, and the picnic areas at the Sanibel Boat Ramp, through Labor Day</li> <li>✓ Through Labor Day consumption or possession of alcohol on all City operated beaches &amp; associated parks and picnic areas with paid public parking, by groups of 10 or more persons require a City of Sanibel Special Event Permit</li> </ul>
<p><b>PLACES OF PUBLIC ACCOMMODATION</b></p> <ul style="list-style-type: none"> <li>✓ All places of public accommodation on Sanibel are strongly encouraged to follow the guidelines set forth by the Sanibel-Captiva Chamber of Commerce, SANCAP SAFE RESOURCES at: <a href="https://members.sanibel-captiva.org">https://members.sanibel-captiva.org</a></li> <li>✓ Ordered to strictly adhere to CDC guidance to stop the spread of COVID-19</li> </ul>	<p><b>RESIDENT &amp; PROPERTY OWNER BEACH PARKING PERMITS</b></p> <ul style="list-style-type: none"> <li>✓ Parking permits for Sanibel residents &amp; property owners for sale at the Sanibel Recreation Center, currently operating M-F, 8am-5:30pm, (239)472-0345</li> </ul>
<p><b>MUSEUMS</b></p> <ul style="list-style-type: none"> <li>✓ May operate up to 50% capacity indoors</li> <li>✓ Check directly with each museum for current operations</li> </ul>	<p><b>PUBLIC LODGING ESTABLISHMENTS</b></p> <ul style="list-style-type: none"> <li>✓ Vacation Rental, Hotel, Motel &amp; Timeshare (as each is defined by FL Statute) reservations made with guests from areas identified by the Governor currently as high risk (New York, New Jersey, and Connecticut), must be for periods longer than the quarantine period establish by the Governor</li> <li>✓ International travelers prohibited</li> <li>✓ Must adhere to the State approved Second Amended Lee County Safety Plan</li> <li>✓ Hotel, Motel &amp; Timeshare occupancy caps removed</li> </ul>
<p><b>RETAIL</b></p> <ul style="list-style-type: none"> <li>✓ May operate at full capacity with responsible social distancing and sanitization protocols</li> <li>✓ May temporarily display merchandise outdoors until Labor Day</li> </ul>	<p><b>CITY OF SANIBEL RECREATION CENTER &amp; PLAYGROUNDS</b></p> <ul style="list-style-type: none"> <li>✓ Registration for youth "Summer Camp" currently open – <a href="#">click for details</a></li> <li>✓ Community Park &amp; Bowman's Beach Playgrounds are open</li> </ul>
<p><b>PRIVATE FITNESS CENTERS</b></p> <ul style="list-style-type: none"> <li>✓ May operate at full capacity with responsible social distancing and frequent sanitization protocols</li> </ul>	<p><b>ENTERTAINMENT BUSINESSES</b></p> <ul style="list-style-type: none"> <li>✓ Including but not limited to movie theaters, concert houses, auditoriums and playhouses may operate at 50% capacity with appropriate social distancing and sanitization protocols.</li> </ul>
<p><b>RESTAURANTS &amp; FOOD ESTABLISHMENTS</b></p> <ul style="list-style-type: none"> <li>✓ May allow bar-top seating with appropriate social distancing</li> <li>✓ May operate up to 50% indoor capacity</li> <li>✓ City of Sanibel has issued authorization for additional outdoor seating</li> </ul>	<p><b>WEDDINGS</b></p> <ul style="list-style-type: none"> <li>✓ Temporary restrictions on issuing Special Event permits for Weddings lifted</li> </ul>
<p><b>PERSONAL SERVICES BUSINESSES</b></p> <ul style="list-style-type: none"> <li>✓ Barber shops, hair salons, tanning salons &amp; nail salons may operate while adhering to guidance from the FL Department of Health</li> </ul>
